 - c) Opening of Tenders shall be on 11/05/2011 at 11:30 AM at the Board Room of second floor of Administration block, Civil Hospital Karachi.
 - d) Pre-bid Meeting will be held in the office of Project Director on 22/04/2011 at 11:00 AM.
2. Tenders documents will be issued to the Firms having experience of not less than Ten Years of these works and its brand should be operational for the last 10 Years in Pakistan.
3. The Contractors must mention their complete & correct present postal address in tender documents & quote the rates both in words & in figures. Incomplete / conditional tenders will not be accepted.
4. The firm should be registered with Pakistan Engineering Council in category C-5 with field of specialization M-03
5. Only duly authorized sole distributors / dealers / agency holders of lift of U.S.A, Western Europe or Japanese origin / manufactured / assembled having sufficient maintenance / backup facilities. Only duly authorized sole distributors and agency holders of elevators manufactures from USA, Western Europe or Japanese origin with

- adequate maintenance/backup facilities shall be allowed to participate in this tender. The same can be inspected before issue of Tender.
6. The Firm should also submit an Affidavit that this firm has never been blacklisted and also has not indulged in fraudulent practice of using sub-standard parts in Elevator etc other than specified in the Agreement. Even at a later stage after Work Order / Supply Order, in case it is found that wrong affidavit has been submitted, the Supply Order will be cancelled without notice.
 7. All elevator accidents in the last 10 years should be reported in a separate Affidavit with details of building/site name, date, type of accident, number of injured, number of deaths due to the accident. Any cover-up or failure to disclose any such instance shall automatically disqualify the Firm/bidder.
 8. The Firm should also submit Affidavit stating of its involvement or not in any type of litigation with a government body, semi-government body or a private entity.
 9. The Contractors shall have to deposit 2% Earnest Money of the quoted Rates (Refundable after finalization of tender in case of unsuccessful bidders) in the shape of pay-order of any scheduled Bank, drawn in favour of Project Director Shaheed Mohtarma Benazir Bhutto, Accident, Emergency & Trauma Centre And Ancillary Services Complex At Civil Hospital Karachi while submitting the tender documents, failing which the tender will be treated as cancelled.
 10. In case of holiday on the date of opening, tenders will be opened on next working day of the date of opening at same time.
