**NOTICE INVITING TENDERS**

- The District Officer, Education Works, Works & Services Department Sukkur has received a loan / Grant / Credit / fund from the Donor / Government to be applied towards the Rehabilitation of School works (Construction of Shelterless Primary School and Missing Facilities, Additional Class Rooms) and intends to apply the funds to cover eligible payments under the contract for Taluka based Projects. Bidding is open to all bidders from eligible source as defined in part One (FIXED) of the Bidding Documents for National Competitive Bidding Procurement of works - small contractors containing the condition of contract.

- Bids shall be valid for a period of 35 Days after bid opening and must be accompanied by bid security of 3% in shape of call deposit in the name of District Officer, Education Works, Works & Services Sukkur, from any scheduled bank of Pakistan at the time of receiving and opening of tenders on the dates mentioned as under. at 1:00 PM, in the presence of tender opening / evaluation committee Sukkur, comprising the District Coordination Officer Sukkur, Executive District Officer Finance Department Sukkur, Executive District Officer Works & Services Sukkur, District Officer Education Works Sukkur, and Divisional Accounts Officer of this office and the bidders are there authorized representative who wish to be present.
- All bidders shall be required to submit with their bids qualification information specified in the bidding Documents. This information shall be used to establish through post qualification whether the bidder is qualified to performed the work.
- Bids are required to be submitted on item rate basis (Not on the basis of the Composite Schedule of Rate with percentage premium) and the rates and amount (In Rupees) must be filled by the bidders for each item in the Bill of Quantities and provide a total Price. Non Compliance may result in rejection of bid.



- 7 In case of dispute, resolution mechanism will be as per SPPRA rules 2010.
- 8 As provided in the bidding documents bidders engage corrupt or fraudulent practices (including collusion / cooling) will be declared ineligible either indefinitely or for a stated period of time to be awarded a contract funded by the Government.
- 9 Tenders will be issued to bidders who possess (10 Years) experience in the Electric works such certificate of works & Services Department is required to be attached with the application of bidder.
- 10 Application Demanding for tenders must be supported with the complete profile of technical works executed previously and financial documents for scrutiny.
- 11 The competent authority reserves the right to reject any or all tenders subject to the provision of SPPRA rules 2010.
- 12 For any other requirement please refer to bid documents .
- 13 If any of the information furnished by the contractor / firm proves to be false at any stage the contract even if awarded is liable for cancellation and other legal action legal and otherwise will be taken against the contractor / firm.
