The terms and conditions for hiring of private Godowns are as under:-

- a. The Godowns must not be situated in low lying / flood hit / water logged / non-environment friendly area and should have easy access to main metalled road.
- b. The Godowns must have provision of electricity and water.
- c. The Godowns' capacity of a unit should be a minimum of 500 metric tons with roof height of at least 20 ft.
- d. There should be no electrical leakage in the roof and walls and must be fit for air-tight arrangements (fumigation).
- e. Floor of the Godowns must be at a raised level compared to its surrounding area.
- f. Floor and walls of the Godowns should be plastered and pit-free.
- g. To avoid long queues at the Godowns, there should be enough room for maneuverability of trolleys / trucks.
- h. From security point of view, the Godowns' space should have a boundary wall.
- i. The rent will be payable only for the period in which the space is utilized.
- j. The execution of the agreement will be made with successful party under usual terms and conditions for the period of six (6) months, which can be extended as per further requirement of Food Department, accordingly.
