
**TENDER NOTICE**

Sealed tenders on prescribed proforma in duplicate along with 2% earnest money of the total bid in the form of Pay Order (Payee's A/c in favour of PPO Sindh) should be dropped in the tender box kept in office of AIGP (Logistics), 2<sup>nd</sup> floor Central Police Office, I.I. Chundrigar Road, Karachi on "~~14~~05.2011" 1400 hours.
3. The tender shall be opened on 14.05.2011 at 14:30 in presence of Purchase Committee and in presence of representatives of bidders who choose to be present on the occasion, in the Committee Room of Central Police Office, Sindh, Ground Floor, I.I.Chundrigar Road, Karachi.
4. Only firms/Companies registered with Income Tax and Sales Tax department are eligible to participate in the tenders (Documentary proof required).
5. Only bids offered on the prescribed tender form issued by the Police Department shall be accepted. However, additional sheets may be attached, if required.
6. Conditional tender / application will not be entertained.
7. Supply must be completed within 15 days and handed over on (F.O.R) destination at the office of undersigned.
