- 2- The tender documents (Soft Copy of Terms & Conditions and Hard Copy of BOQ / Schedule-B) will be issued to the Contractor on submission of written request on letter head alongwith original documents with their photocopies as mentioned above and on payment of non refundable cost of tender price through pay order from any schedule Bank prepared in favour of CDGK. Bid Security in shape of pay order from any schedule Bank in favour of CDGK as mentioned above should be enclosed with the bid otherwise the tender will be rejected. No tender will be sold on the tender opening date. The terms & conditions of the tender and contract can also be download from WEB Site of CDGK). However the BOQ / Schedule-B shall must be purchased from the above mentioned office on payment of the prescribed fee and within the specified time.
- 3- In case of any reason, if the tenders are not responded on the above dates the next date of submission and opening will be 27-05-2011 and the tender documents will also be available for sale from 19-05.2011 to 26-05-2011

- 4- In case the date of opening or last date of sale is declared as a public holiday y the Government, the next official working day shall be deemed to be the date for last date of sale and submission and opening of tenders at the same time as mentioned above.
- 5- The total bid amount as well as the rates of items must be filled both in figures and words and in case any corrected is made by the Contractor himself then each correction must be initialed by the Contractor, otherwise the tenders are liable to be summarily rejected.

SUBSTANTIALLY RESPONSIVE BID

- 6- Only those bids, which comply with the requirement upgraded separately on CDGK WEB site and attached with the tender documents, shall be declared substantially responsive bids at the time of tender opening and will be eligible for further evaluation, otherwise the same will be declared as non responsive / rejected.
- 7- The bidders are required to submit the above information, the signed evidence against evaluation criteria along with their bids. However joint Venture between two or more firms is allowed subject to compliance of conditions of stipulated rules of PEC.
- 8- If any fake documents are found then tender is liable to be rejected / cancelled with out any compensation and with penalty as per rules.
- 9- Canvassing in connection with tenders is strictly prohibited and tenders submitted by the Contractors who are reported canvassing will be liable for rejection.
- 10- If a bidder submits a security unbalanced bid then he will be required to deposit extra performance security to a level sufficient to protect the procuring agency against financial losses, failing which the submitted bid security will be forfeited by the procuring agency.
- 11- Bid security of the unsuccessful bidders shall be released once the contract has been finalized with the successful bidder or the validity period has expired.

12- The procuring agency may reject all or any bid subject to the relevant provisions of SPPRA Rules 2010.
