2. The amount of 02% Earnest Money of Total Value of Quoted Tender must be attached with tender documents in shape of pay order in favor of **Town Municipal Administration Landhi** without which the tender will be treated as Cancelled.
3. The Contractors must mention their complete and correct present postal address in tender document and quote the rates both in words and in figures. Incomplete / conditional tenders will not be accepted.
4. All tenders shall be dropped in the box placed in the Office of the Chairman Tender Opening Committee on or before 16.05.2011 upto 12:00 P.M.
