Prison-wise Bid for supply of cooked food and Miscellaneous Articles (Item-wise) shall be separate and accompanied with Pay Order / Demand Draft of any schedule Bank of Pakistan as bid security @ the rate of Rs.3% of the total cost of the bid in favour of Inspector General of Prisons Sindh which will remain deposited till completion of the process as per rule. The Bid without requisite bid security or less will be rejected.
- The Bid document can be obtained upto 30.05.2011 from the date of publication of Bid notice in news papers as well as SPPRA's website.
- 5. Bid document will be received upto 01.06.2011 (12.00 Noon) by hand only at the office of the Inspector General of Prisons Karachi Camp at Central Prison Karachi and will be opened at 12:30 Noon same day in presence of Bidders who wish to be present. - d) Current Bank Certificate with present balance (in original) to the effect that financial position of contractor / firm is sound alongwith (turn over of at least last 3 years). Prisonwise requirement of financial soundness attached with Bid Document.
- f) Bid Security in shape of Pay Order / Demand Draft in original @ the rate of Rs.3% of the total cost of bid.
- g) An affidavit of Rs.100/- Stamp paper duly authenticated by Notary Public to the effect that the firm or contractor has never been black listed by any Government, Semi-Government Department or Private Department and not bank loan, Government dues defaulter and also not involved in any corrupt or criminal proceedings or activities.
- h) Copy of valid CNIC of the bidder duly attested.
- Relevant experience supply of cooked food and Miscellaneous Articles, copies of work orders alongwith satisfactory completion of contract certificate (Government organization will be preferred).
