- Each bid shall comprise a single package containing two separate envelopes. Each envelop should contain separate Financial proposal and Technical proposal. The envelopes should clearly marked as "Financial Proposal" and "Technical Proposal" in bold legible letters to avoid confusion. Initially only the envelope marked "Technical Proposal" shall be opened.
- Envelope marked with "Financial Proposal" will remain in the custody of procurement agency without opening the same. The Committee will evaluate the Technical proposal and those proposals will be rejected which do not conform to specified requirements the terms and conditions.
- During the technical evaluation no amendments in technical proposal shall be allowed.
- Financial proposal shall be opened at the time, date and venue communicated to bidders in advance.
- The financial proposals of bidder found technically non-responsive shall be returned un opened to respective bidders.
- In complete or conditional tenders can not be considered or entertain.

The Departmental Purchase Committee may reject all or any bid or proposal at any time prior to the acceptable of a bid or proposal, subject to relevant provisions of PPRA Rules.
