
### LIST OF WORKS ATTACHED.

2. The tenders will be received back on **27.05.2011** upto 1.00 PM and opened on the same day at 2:00PM in the presence of tender opening/evaluation committee and the bidder or their authorized representatives who wish to be present.
3. If due to some certain official activities, the undersigned is out of headquarter, or in case the tenders are cancelled/ rejected or un-responded, the next dates for issue and opening will be as under.

4. Eligibility conditions for intending participants are as under:-
  - a. Valid Registration with Pakistan Engineering Council in the relevant field of specialization of work and to the extent of tender amount of each work except the works below costing Rs: 2.50 (M).

  - c. Bio-Data of Technical staff employed and to be made available for working on the project.
  - d. Details of works executed during the last five years including copy of certificate for satisfactory completion of works by the employer.
  - e. Documentary proof and ownership of available machinery and T&P.
  - f. List, scope and approximate cost of works in hand.
  - g. Finance stability certificate issued by a scheduled Bank.
  - h. Affidavit in which the bidder undertakes that it is not involved in any litigation or abandoned any work in the department.
  - i. Affidavit in which it should be undertaken that the information/particulars provided by him is true and correct.
  - j. Affidavit that the bidder has not been black listed by any Government /Semi Government/ Autonomous body.
  - k. Registration (NTN certificate) from income Tax department along with CNIC.


