**TENDER NOTICE**

Sealed tenders are invited from the reputed firms for the Procurement of one Patrol boat of following specification at Karachi Fish Harbour.

Size: L=9m, W=2.8m, Draft=1.2m Hull - GRP,  
Engine - Marine (Diesel) 200HP  
Shall be equipped with GPS, Horn, Search Lights, Fender, Propeller,  
Bilge Pumps, Anchor, Insulated Cabin, Magnetic Compass, VHF, Life  
Jackets, Life Buoy, Fire Extinguishers, etc.

Bids shall be accepted under the "single stage – two envelope procedure" defined under rule 46(2) of Sindh Public Procurement Rules 2010, according to which; "the bid shall comprise a single package containing two separate envelopes. Each envelope shall contain separately the Technical and financial proposal. Initially only the envelopes marked 'Technical Proposal' shall be opened. The envelopes marked as Financial Proposal shall be retained in the custody of the Employer. The Financial Proposals of the technically accepted bids only shall be opened at the date, time and place communicated to the bidders, in advance." Further details can be seen in the Tender Documents.

Tender Documents can be purchased by interested bidders from the office of Accounts Officer, KFHA on payment of a Tender Fee i.e. Rs.2000/- (non-refundable) up to 30<sup>th</sup> May, 2011 during office hours.

All bids must be accompanied by an Earnest Money equivalent to **3.5%** of the bid quoted, in favour of Karachi Fisheries Harbour Authority in the form of Pay Order or an irrevocable Bank Guarantee from any scheduled bank of Pakistan. The bids without Earnest Money will not be considered and rejected. Bids shall reach the office of Managing Director, KFHA on 31<sup>st</sup> May, 2011 by 1300 hours. Bids will be opened on the same day at 1400 hours in presence of bidders or their representatives who may wish to be present.
