- During the technical evaluation no amendments in the technical proposal shall be permitted.
- The Financial Proposal of bids shall opened publicly at a time, date and venue announced and communicated to the bidders in advance.
- The Financial Proposal of bids found technically non-responsive shall be returned unopened to the respective bidders.
