- The envelop marked as "Financial proposal" shall be retained in the custody of the procuring agency, who will evaluate the Technical Proposal without referring to the price and reject any proposal which does not confirm to the specific requirement.
- During the technical evaluation no amendments in the technical proposal shall be permitted.
- The Financial Proposal of bids shall opened publicly at a time, date and venue announced and communicated to the bidders in advance.
- The Financial Proposal of bids found technically non-responsive shall be returned unopened to the respective bidders.
