- 3. In case of any reason, if the tenders are not responded on the above date the next date of submission and opening will be 11-6-2011 and the tender documents will also be available for sale from 03-06-2011 to 08-06-2011.
- 4. In case the date of opening is declared as a public holiday by the Government, the next official working day shall be deemed to be the date for submission and opening of tenders at the same time as mentioned.
- 5. The total bid amount as well as the rates of items must be filled both in figures and words and in case any correction is made by the contractor himself then each correction must be initialed by the contractor; otherwise the tenders are liable to be
- 6. The eligibility criteria for the bidders shall be as under:-
