- b) The Godowns must have provision of electricity and water.
- c) The storage capacity of a unit should be minimum of 500 metric tons with roof height of at least 20ft.
- d) There should be no electoral leakage in the roof and walls and must be fit for air tight arrangements (fumigation).
- e) Floor of the Godowns must be at a raised level from its surrounding area.
- f) Floor and walls of the Godowns should be plastered and pit free.
- g) There should be enough space for loading and unloading of wheat stocks from the trucks.
- h) From security point of view the Godowns space should have a boundary wall.
- i) The execution of the agreement will be made with successful party under usual terms and conditions initially for the period of (06) six month, which can be extended as per further requirement of Food Department accordingly.
- j) The rent will be payable only for the period in which the space is utilized i.e. from the date of possession to date of vacation
