The tender documents will be available in the office of the Deputy Secretary (W&D), Population Welfare Department, Sindh, Karachi, 61-A, Kathiwar Cooperative Housing Society, Karachi, available from 30th May, 2011, till the date of closing i.e. 13th June, 2011 upto 11.00 AM, tender will be opened on the same day at 11.30 AM.

Tenders should be submitted in the Tender forms which can be purchased from the office of the undersigned, Population Welfare Department, 61-A, Kathiwar co-operative Housing Society, Karachi, on the payment of the tender fee in shape of Pay order. The bidder are required to furnish Bid Security @2.5% of the total bid amounts in the shape of Pay order in favour of Secretary, Population Welfare Department, Government of Sindh, Karachi. In case of alternate offer separate tender documents should be purchased and offer should be submitted with the separate Bid Security. Any offer without 2.5% Bid Security will be rejected. The department may reject all bids or proposals at any time prior to the acceptance of bid or proposal. The Department shall upon request communicate to any supplier or contractor who submitted a bid or proposal, the grounds for its rejection of all bids or proposals, but is not required to justify those grounds.
