NOTICE INVITING TENDER (AS PER SPPRA GUIDELINE)

Sealed Tenders on B-I / B-2 forms are hereby invited from interesting participants, reputed & experienced firms / contractors registered with the Pakistan engineer Council under SPPRA Rules 2010 for the category reflected against the schemes as per list attached.

TERMS & CONDITIONS:-

- 2. The tender(s) in sealed cover superscripted with the name of work should be dropped in the tender box kept in the office of the undersigned by 2:00 pm on 15-06-2011 and opened by the Tender Opening Committee on the same day at 3:00 pm in the presence of those representatives who wish to be present.
- 3. In case of any reason the tenders are not responded on the above dates, the tender(s) will be issued upto 1:00 pm on 17-06-2011 and received on 18-06-2011 till 2:00 pm and will be opened on the same day at 3:00 pm.
- 4. In case the date of opening is declared public holiday by the Government, next official working day shall be deemed to be the date of submission and opening of tender(s) at the same time.
- 5. The total bid amount as well as the rates must be filled both in figures and works and in case any corrections made by the contractor himself then each correction must be initiated by the contractor, otherwise the tender(s) are liable to be summarily rejected.
- 6. Earnest Money / Bid Security of the bidders shall be retained till final decision on the tender(s).

- 7. The eligibility criteria for the bidders shall be as under :
 - i. Specialization of work in the concerned field and registration with PEC according to the value of tender(s) (in original).
 - ii. Particulars of Engineers and Technical staff working with firm.
 - iii. Documentary evidence regarding under completion / completed works alongwith satisfactory completion certificate from the concerned Department.
 - iv. List of on-going works with details and work order.
 - v. List of available machinery / equipment.
 - vi. Bank Statement of last three years.
 - vii. NTN Certificate from Income Tax Department with copy of CNIC.
 - viii. Affidavit to the effect that the firm is not involved in any court case and that no work has been left by the firm incomplete.
 - ix. Certificate from Register of companies with memorandum of articles and association in case the firm is a private limited company and registered partnership deed in case the firm is run by partners.
- 8. The bidders are required to read the requirements and conditions of bidding documents carefully and submit their bids with all required information accompanied with the documents required under Clause-I/B-II. Non responsive bids in terms of bidding documents are liable to be rejected.
- 9. If any fake document(s) are found then the tender is liable to be rejected / cancelled without any compensation and with penalty as per rules.
- 10. Canvassing in connection with tender(s) is strictly prohibited and tenders submitted by the contractors who are reported to be involved in canvassing will be liable for rejection.
- 11. Tender description and date of opening should be mentioned on the envelope.
- 12. Tenders received after specified time and date will not be considered.
- 13. Conditional tenders and those without earnest money shall be entertained.
- 14. An affidavit to the effect that the firm / contractor is not blacklisted by any executing agency should be enclosed with the bid.
- 15. The Department may reject any or all bids subject to the relevant provisions of SPPRA Rules 2010.
