5. The total bid amount as well as the rates of items must be filled both in figures words and in case any correction is made by the contractor himself then each correction must be initialed by the contractor, otherwise the tenders are liable to be summarily rejected.

6. Substantially Responsive Bid

Only those bids, which comply with the each minimum qualification attach criteria attached with the tender documents shall be declared substantially responsive bids at the time of tender opening and will be eligible for further evolution, otherwise the same will be declared as non responsive / rejected.

7. The bidders are required to submit the above information the signed evidence against evolution criteria along with their bids. However joint Venture between two or more firms is allowed subject to compliance of condition of stipulated rules of PEC.

8. If any fake documents are found then the tender is liable to be rejected/cancelled without any compensation and with penalty as per rules.

9. Canvassing in connection with tenders is strictly prohibited and tenders submitted by the contractors who are reported canvassing will be liable for rejection.
