Terms & Conditions

- Publisher will have to provide call deposit at the cost of Rs. 10,000/- or 5% of bid amount which ever is higher in the favor of Peoples University of Medical & Health Sciences for Women Shaheed Benazir Abad, in case of failure the tender document will not be entertained (Total Amount of call deposit will be re-fixed at 5% at the time of issue supply order)
