Bid shall be valid for a period of 35 days after Bid opening and must be accompanied by bid security of 3% in the shape of call deposit in the name of District Officer (Education Works) W&S Matiari from any schedule Bank of Pakistan at the time of receiving of tenders on the dates mentioned as under @ Government Boys Degree College Matiari at 1:00 pm on 20.06.2011 which will be opened on same day at 2:00 pm on 20.06.2011 in presence of tender opening / procurement committee, bidders and their authorized representative who wish to be present.
- 5. All bidders shall be required to submit their bids, qualification information specified in the bidding documents. This information shall be used to establish through post-qualification whether the bidder is qualified to perform the work.
- 6. Bids are required to be submitted on item rate basis (not on the basis of Composite Schedule of Rates with percentage premium) and the rates and amounts (in Rupees) must be filled by the bidders for each item in the Bill of Quantities and provide a total price. Non-compliance may result in rejection of bid.

7. In case of dispute, dispute resolution mechanism will be as per SPPRA rules 2010.

8. As provided in the bidding documents, bidders engaging in corrupt or fraudulent practices (including collusion / pooling) will be declared ineligible, either indefinitely or for a stated period of time, to be awarded a contract funded by the Government.

9. Tenders will be issued to bidders who possess 10 years experience in bidding works such certificate of Works & Services Department is required to be attached with the application of bidders.

10. Applications demanding for tenders must be supported with the complete profile of technical works executed previously & financial documents of security.

11. The Competent Authority reserves the right to reject any or all tenders subject to relevant provisions of SPPRA Rules 2010.

12. For any other requirement, please refer bid documents.

- 13. If any of the information furnished by the Contractor / firm proves to be false at any stage, the contract, even if awarded, is liable for cancellation and other action, legal and otherwise, will be taken against the contractor / firm.
- 14. No tender will be issued without *Electrical License* under rule 48 of the Electricity Rules 1937.
