2. 5% of the Bid Amount shall be furnished with the tender in the shape of call deposit / pay order from the schedule bank in the name of Medical Superintendent / Civil Surgeon Services Hospital Hyderabad. Earnest money in shape of cheque or in cash shall not be accepted at all.
3. Contractor will not be allowed to withdraw tender and ask for the refund of earnest money before opening of tender or expiry of the bid validity, failing which the same will be forfeited to the department.
4. Tender document can be obtained from this office, M&I Cell of Health Department, Government of Sindh, Block No. 24 Shahrach-e-Liaquat, Karachi & Director General Health Services Sindh at Hyderabad on payment of the cost of tender fee of Rs. 1000/-(Non-Refundable).
5. Security deposit at the rate of 08% and income Tax 3.50% of firm / supplier who are registered with income tax department.
6. Sale Tax will be applicable / deducted as specified in sale tax acts 1990 and with holding rules 2007.
