3. Opening of Tender	<u>23-06-2011</u> at 2:30 pm	Office of DO (Safari), Main University Road, Gulshan-e-Iqbal, Karachi.

2. The Tender documents will be issued to all such interested parties who are registered with Sales Tax Directorate Registration if applicable, on written request subject to payment of non-refundable cost of tender through pay order from any schedule bank drawn in favour of CDGK.
3. In case of any reason, if the tenders are not responded on the above dates, the next date of submission and opening will be 23-06-2011 and the tender documents will also be available for sale from 24-06-2011 to 27-06-2011.
4. Tenders in sealed cover superscripted with the name of work should be dropped in the Tender Box placed in the office mentioned above.
5. In case the date of opening is declared as a public holiday by the Government, the next official working day shall be deemed to be the date for submission and opening of tenders at the same time.
6. 2% Earnest Money / Call deposit of bid amount in form of pay order of any schedule bank in favour of CDGK enclosed with the tender shall be retained till expiry of the bid validity period / finalization of the case, which ever is earlier.
7. Canvassing in connection with tenders is strictly prohibited and tenders submitted by those contractors who are reported canvassing will be liable for rejection.
8. Tenders will not be allowed to be dropped after the schedule time and that unsealed covers / envelop shall not be entertained.

9. The total bid amount as well as the rates of items must be filled both in figures and words and in case of any correction made by the contractor himself then each correction must be initialled, otherwise, the tenders are liable to be summarily rejected.
10. Tenderers must be registered with Income Tax Department.
11. The procuring agency may reject any or all bids, by the contractor subject to relevant provisions of SPP Rules-2010.
