The Financial proposal of eligible contractors/suppliers will also be opened on same date at 1-00 PM in the same office.

### TERMS AND CONDITIONS.

1. The contractors/suppliers/interested persons shall submit an application alongwith order of tender fee for purchase of tender form/bid documents
2. All the contractors' suppliers and interested persons shall submit the 3% of the total quoted cost as bid security at the time of submission of bids/tender forms in shape of pay order in favour of Project Director Khairpur Economic Zone, Khairpur in a sealed envelop.
3. The time for supply of required items has been fixed for 20 days after issuance of supply order.
4. The procuring Agency may reject all or any bid or proposals at any time prior to acceptance of a bid or proposal, subject to the relevant provision of SPPRA Rules, 2010
5. The purchase committee may decrease or increase the number of items required in the tender in accordance of SPPRA rules, 2010
6. The tender who does not fulfill the terms and conditions will not be entertained.
7. The Government notified black listed contractors suppliers/persons shall not be entertained.
8. The successful contractor's suppliers will have to execute an agreement on stamped paper to the effect that he has accepted the conditions of contract and he has not been black listed by any Government/Semi Government / Autonomous Bodies.
9. In case the tender is not opened on scheduled date due to any reason than the same shall be opened on next working day or as circulated on the scheduled date.
10. The contractor/ interested persons is required to produce photograph along with detailed specification of the items required items on separate sheet/letter head. The committee will approve items in view of specification required.
11. The Single stage-two envelop procedure will be adopted; the contractors/suppliers are required to submit their sealed bids in two separate envelops, clearly marked as financial proposal & Technical proposal. The item wise rates should be quoted including all Government taxes in financial proposal, whereas the technical proposal should include complete Bio- data of company/firm/contractor. NTN/GST certificate, details of experience etc.
