- In case of any reason, if the tenders are not responded on the above dates the next date of submission

- 3. The tender documents will be issued to the contractor on submission of written request on letterhead and on payment of non-refundable cost of tender price through pay order from any schedule Bank in layor of CDGK. Bid Security in shape of pay order / bank guarantee from any schedule Bank in layor of CDGK as mentioned above should be enclosed with the bid otherwise the tender will be rejected. No tender will be sold on the tender opening date.

- In Case the date of opening or last date of sale is declared as a public holiday by the Government, the next official working day shall be deemed to be the date for last date of sale and submission and opening of tenders at the same time as mentioned above.
- The total bid amount as well as the rates of items must be filled both in figures and words and in case any 5. correction is made by the contractor himself then each correction must be initialed by the Contractor, otherwise the tenders are liable to be summarily rejected.

6. Substantially Responsive Bid:-

Only those bids, which comply with each condition of eligibility as well as minimum qualification criteria attached with the tender documents shall be declared substantially responsive bids at the time of tender opening and will be eligible for further evaluation, otherwise the same will be declared as non responsive / rejected.

- The bidders are required to submit the above information, the signed evidence against engibility criteria / minimum qualification criteria along with their bids. However Joint Venture between two or more firms is allowed subject to compliance of conditions of stipulated rules of PEC.
- If any fake documents are found then the tender is liable to be rejected/cancelled without any 8. compensation and with penalty as per rules.
- Canvassing in connection with tenders is strictly prohibited and tenders submitted by the contractors who are reported canvassing will be liable for rejection.
- If a bidder submits a seriously unbalanced bid then he will be required to deposit extra performance 10. security to a level sufficient to protect the procuring agency against financial losses, failing which the submitted bid security will be forfeited by the procuring agency.
- Bid security of the unsuccessful bidder shall be released once the contract has been finalized with the successful bidder or the validity period has expired.
- The procuring agency may reject all or any bid subject to the relevant provisions of SPPRA Rules 2010. 12.
