BIDDERS QUALIFICATION / ELIGIBILITY CRITERIA

- 1- Bidding documents will be issued only Bidders who strictly qualify the eligibility
- a. Registration with Pakistan Engineering Council in the relevant category or above discipline of Bid cost.
 - b. For Electric Works valid license issued from inspectorate of Electrical Licence, Government of Sindh of the similar Region with respect to works shown above will be considered
 - c. List of original works or buildings either construction or in hand having 500 Sft to 2,000 Sft or above plinth area in last 3 years (proof in the shape of work order completion certificate is mandatory)
 - d. List of Rehabilitation / Maintenance and Repair of Buildings either construction or in hand having 500 Sft to 2,000 Sft or above plinth area in last 3 years (proof in the shape of work order and completion certificate mandatory)
 - e. Turn over of last 3 years in the shape of Bank Statement from any Scheduled Bank equivalent to Bid cost and having 20 % amount available as the balance in the Bank Accounts with respect to Bid cost.
 - f. Valid Registration with Federal Board of Revenue (FBR) for income Tax (NTN).
 - g. Valid Registration with the Sindh Revenue Board (SRB).
 - h. The Bid Security 5% (five percent) of Bid amount in the shape of call deposit / pay order issued from any schedule Bank of Pakistan in favour of Executive Engineer Education Works Division District West Karachi , shall be submitted at the time of submission of Bidding Documents.
 - i. Full name, complete address, telephone number, fax number, e-mail of the organization.
 - j. Copy of CNIC of proprietor / partner (if any).
 - k. Undertaking on stamp paper of Rs.200/= that firm is not involved in any litigation, Department Rift, or has left the previous work awarded or on un-necessary delay in completion of any work in the Education Works or in other Department.
 - l. Undertaking on stamp paper regarding Non-Black listing of firm previously by Government's Semi Government's and Autonomous Bodies.
 - m. Undertaking regarding list of Partners / Partnership Deed with Directors / Proprietors etc with complete information along with Power of Attorney /Sole Proprietor.
 - n. Undertaking stamp paper that information submitted by Bidder / Firm is correct if found misleading at any stage the work awarded will be cancelled.
 - o. in case of holiday and unforeseen circumstances on opening date, the bids shall be **submitted and opened on the next working day**. Other terms and condition shall remain the same.
 - p. In-complete / conditional Bids will not be entertained and will be rejected out rightly.
